

**GRANBY SANITATION DISTRICT
SPECIAL DISTRICT PUBLIC DISCLOSURE DOCUMENT**

Pursuant to C.R.S. § 32-1-104.8, Granby Sanitation District provides the following information:

- (a) **The Name of the District:** Granby Sanitation District.
- (b) **District Boundary Map:** Recorded contemporaneously herewith is a current map of the Granby Sanitation District's boundaries.
- (c) **Powers:** The powers of Granby Sanitation District as authorized by its Statement of Purpose and C.R.S § 32-1-101, *et. seq.*:
 - (1) The purpose of Granby Sanitation District as stated in its Statement of Purpose:

"Construction, laying and installation of sewer mains and the erection and construction of a sewage disposal plant, together with all improvements and appurtenances as will be reasonably necessary to adequately providing sewage disposal for said District."
 - (2) Granby Sanitation District is not a metropolitan district as defined in C.R.S. § 32-1-1004, but its general powers as a sanitation district are found under C.R.S. § 32-1-1001 and C.R.S. § 32-1-1006, as well as financial powers under C.R.S. § 32-1-1101. Granby Sanitation District is generally governed by the provisions of C.R.S. § 32-1-101, *et. seq.*, and other Colorado statutory provisions.
- (d) Granby Sanitation District's Statement of Purpose, which can be amended from time to time, includes a description of the District's powers and authority. A copy of Granby Sanitation District's Statement of Purposes is available from the Division of Local Government in the Colorado Department of Local Affairs.
- (e) **GRANBY SANITATION DISTRICT IS AUTHORIZED BY TITLE 32 OF THE COLORADO REVISED STATUTES TO USE A NUMBER OF METHODS TO RAISE REVENUES FOR CAPITAL NEEDS AND GENERAL OPERATIONS COSTS. THESE METHODS, SUBJECT TO THE LIMITATIONS IMPOSED BY SECTION 20 OF ARTICLE X OF THE COLORADO CONSTITUTION, INCLUDE ISSUING DEBT, LEVYING TAXES, AND IMPOSING FEES AND CHARGES. INFORMATION**

CONCERNING DIRECTORS, MANAGEMENT, MEETINGS, ELECTIONS, AND CURENT TAXES ARE PROVIDED ANNUALLY IN THE NOTICE TO ELECTORS DESCRIBED IN SECTION 32-1-809 (1), COLORADO REVISED STATUTES, WHICH CAN BE FOUND AT THE DISTRICT OFFICE, ON THE DISTRICT'S WEB SITE, ON FILE AT THE DIVISION OF LOCAL GOVERNMENT IN THE STATE DEPARTMENT OF LOCAL AFFAIRS, OR ON FILE AT THE OFFICE OF THE CLERK AND RECORDER OF EACH COUNTY IN WHICH THE SPECIAL DISTRICT IS LOCATED.
